**PORTSMOUTH HOSPITALS NHS TRUST GENERAL CHARITABLE FUND
REPORT TO TRUST BOARD –February 2015**

Issue for consideration:

To update the Trust Board, in their capacity as Trustee, on recent charity activity.

1. Total Funds

Portsmouth Hospitals NHS Trust General Charitable Fund has a fund balance of £2,564,000 as at 31st January 2015.

2. Charitable Income

During the month, the charity received donations, legacy and fundraising income of £38,000, including the following items of note:

- Neo-natal charitable fund raised £10,000 from private donations and gift aid.
- The Cancer Support charitable fund raised over £1,000.
- Renal charity has raised £1,000 through corporate donations and £2000 from fundraising and private donations.
- The Rocky Appeal raised nearly £1,300 through private donations.

3. Charitable Expenditure

During the month, the charity spent £54,000 including the following items of note:

- General Amenities spent £8,000 on staff welfare.
- Renal Charitable Fund spent over £40,000 on three section dialysis electric chairs.

4. The Rocky Appeal

To date net funds of £741,000 have been raised for the Robot. The appeal has funded the first year of the robot lease and associated equipment totalling £504,000. There is currently £237,000 to support future lease costs.

5. Investments

Investments held with Hume Capital on the 31st of January, 2015 amounted to £257,000 and a small investment is held with CCLA of £105,000.
