**PORTSMOUTH HOSPITALS NHS TRUST GENERAL CHARITABLE FUND
REPORT TO TRUST BOARD –March 2015**

Issue for consideration:

To update the Trust Board, in their capacity as Trustee, on recent charity activity.

1. Total Funds

Portsmouth Hospitals NHS Trust General Charitable Fund has a fund balance of £2,619,000 as at 28th February 2015.

2. Charitable Income

During the month, the charity received donations, legacy and fundraising income of £105,000, including the following items of note:

- Endoscopy charitable fund received £72,000 from Gosport League of Friends.
- The Wessex O &G Education charitable fund raised about £2,000.
- A donation of £4,400 was given by the Walter Duncan Trust towards the Paediatric Prosthetic Fund.
- The Lord Mayors stroke fund raised nearly £1,000 from its Tenth anniversary fund raising events.

3. Charitable Expenditure

During the month, the charity spent £50,000 including the following items of note:

- General Amenities spent £3,000 on donation boxes and £5,000 on Consumables for the robot.
- Neonatal fund purchased 14 patient chairs for about £1,000
- Cancer services spend £5,500 on electronic booking form.

4. The Rocky Appeal

To date net funds of £758,000 have been raised for the Robot. The appeal has funded the first year of the robot lease and associated equipment totalling £504,000. There is currently £254,000 to support future lease costs.

5. Investments

Investments held with Hume Capital on the 28TH of February, 2015 amounted to £257,500 and a small investment is held with CCLA of £108,000.
