Thank you for your request for information under the Freedom of Information Act 2000, which was received by the Trust on 18/01/2022. Please see responses to your requests below.

1. Between Feb 2020 and December 2021, did your Trust treat any overseas visitors or migrants (e.g. those usually subject to cost recovery provisions)?

Yes, the Trust did treat overseas visitors and migrants within the timeframe specified.

Eleven of these patients who attended the Trust were treated for Covid-19.

b) How many of these patients did your Trust exempt for charges related to their treatment under the "Guidance on implementing the overseas visitor charging regulations (amended Feb 2020)"?

Eleven patients were exempt for charges due to covid treatment. Three of which were charged for other treatments they received on top of their free covid treatment.
